REGENT'S PLACE AT BEAR LAKES ARCHITECTURAL CONTROL COMMITTEE GUIDELINES

Regent's Place Homeowners

The Architectural Control Committee (ACC) of Regent's Place received the approval of the Board of Directors to incorporate necessary regulations into the Operating Rules (Rules & Regulations).

The following rules are formulated in order to maintain a consistent, harmonious community that is architecturally and artistically pleasing and will maintain or enhance property values.

REGENT'S PLACE ACC GUIDELINES

- 1) Exterior paint colors should reflect the Mediterranean style and design of the house and should enhance the relationship between the surrounding properties and natural environment. All colors are subject to approval by architectural committee.
- 2) Exterior paint colors of zero-lot-line walls shall be compatible with surrounding properties and are subject to ACC approval.

- 3) Roofing colors should be compatible with existing or proposed exterior colors. Only barrel tile roofing is permitted. Roofing materials are subject to ACC approval.
- 4) All signs are subject to approval. No yard signs greater than 6 inches in diameter shall be displayed with the exception of professional security service signs and temporary property for sale signs which have received written approval of the Board as to size, type, style and location.
- 5) Front yard landscaping shall be designed in conjunction with and in harmony with architectural design of the residence
- 6) Prior to starting any architectural improvement members should obtain the Architectural Request Form from Wilson Landscaping & Management Corp. Once the form is properly filled out it is sent to the ACC
- 7) Approval is not required for projects that are considered maintenance such as repainting trim the same color or replacing dying/diseased plants with similar plants, etc.
- 8) The ACC shall, in writing, approve or disapprove of a member's architectural application within 2 weeks of submittal
- 9) Time limitation for completion of any approved architectural improvements shall be 12 months
